The **BiLaP Fellowship program** is pleased to announce the availability of 3 Research Fellowships for the year 2019.

The BiLaP Fellowship program is open to post-doctoral scholars and professors from a foreign research institution or university and offers the opportunity of spending 2 months in residence at Milano-Bicocca University School of Law (please note that months of July and August are excluded). The principal objective of the BiLaP Fellowship program is the advancement of research on law and pluralism issues.

These strategic themes include the following overarching areas:

- Pluralism and Democracy;
- Public Security, Prevention of and the Fight against Terrorism, International Cooperation;
- Pluralism and Criminal Justice;
- Work and Business in Plural Societies;
- Minors and Family in a Plural Context;

The expectation is that the residency of our Fellows at Milano-Bicocca University School of Law will result in at least one paper that will be of sufficient quality to be published as a BiLaP Paper. A seminar at Milano-Bicocca University School of Law is also compulsory.

## Categories of 2019 Fellowship

## Junior Fellowships

- > Participation requirements: PhD candidates in Law or scholars with a PhD in Law.
- Appointed fellows will conduct their research under the supervision of a Senior Fellow for a period of two months (minimum).
- The research program shall be related to one of the themes in the strategic list above mentioned and must be included in the Application. A final working paper is required, as well as a seminar or lectures at Milano-Bicocca University School of Law.
- > Fellows are expected to be in full time residence during their appointment.
- ➤ Total remuneration for the entire period (subject to applicable taxes and including all expenses): € 8000.
- ➢ 3 positions available.

## **Application Deadline**

Candidates must send their application (detailed *curriculum vitae*, research program of approximately 2 pages, one letter of recommendation) to lawpluralism@unimib.it. For further information, please contact <u>stefania.ninatti@unimib.it</u>, <u>nicola.sartori@unimib.it</u>.

The deadline for receipt of BiLaP Fellowship program applications and application materials for the 2018-2019 academic year is **January, 15, 2019**. Applications not received, or not complete, by this time will not be considered for participation in the Fellowship Program for the 2018-2019 academic year.
